New Report Exposes Crisis in Juvenile Justice System and its Devastating Impacts on Families - Solutions Proposed!

Hot off the press! Justice for Families (J4F) and DataCenter are proud to release a new report on the juvenile justice system. The report, titled "Families Unlocking Futures: Solutions to the Crisis in Juvenile Justice," offers first of its kind analysis on how the juvenile justice system actually does more to feed the nation's vast prison system than to deter young people from system involvement. Based on over 1,000 surveys with parents and family members of incarcerated youth and 24 focus groups nationwide, the report presents a body of data never captured or examined before.

Using a participatory model, DataCenter co-led a research process that supported both the leadership development for family members of affected youth and the expansion of J4F's nationwide network. The report examines the juvenile justice system from the perspectives of those who are most impacted - the involved youth and their families.

This comprehensive study reveals the incredible damage that the system causes to families and communities. It aims to correct misperceptions about system-involved youth. It demonstrates the need for families to redesign the juvenile justice system. The report uncovers crucial flaws that burden, alienate, and exclude families from the treatment of system-involved youth. Here are a few of the report's findings:

• States spent \$5.7 billion locking up 64,558 youth in 2007. That's \$88,000 per year per youth or \$240.99 each





families said they have had to choose between paying for basic 91% of survey respondents necessities like food and making said that courts should court-related payments.

involve families more in decisions on what happens that they were never asked to a child found delinquent/ by a judge what should guilty.

More than eight in ten family members surveyed reported happen to their child.

The report illustrates how declining social services and public education combined with aggressive police tactics, zero-tolerance policies, and the rapid growth of the prison system wreak havoc on low-income communities and communities of color.

But Families Unlocking Futures goes beyond elucidating problems of the juvenile justice system—it puts forth viable, proven solutions and offers a blueprint for Youth Justice Transformation.
